

**MEMORANDUM OF UNDERSTANDING
BETWEEN
CENTENARY COLLEGE OF LOUISIANA
AND
BOSSIER PARISH COMMUNITY COLLEGE**

Centenary College of Louisiana (Centenary College) and Bossier Parish Community College (BPCC) have agreed to enter into a Memorandum of Understanding (Articulation Agreement) between the two institutions regarding the acceptance of Louisiana Transfer (LA Transfer) program courses.

This agreement confirms that all credit hours completed for an Associate of Arts in Business, Fine Arts, Humanities, Mass Communication, or Social Sciences as well as an Associate of Science in Biological Sciences or Physical Sciences at BPCC for which the student has scored a C or better will transfer to Centenary College under Centenary's transfer processes and policies and be applied toward the total number of credit hours needed for graduation. In some instances, the credits may also be applied toward course requirements as relevant to a chosen degree.

This partnership is mutually beneficial to both institutions. It benefits both traditional and non-traditional BPCC students by offering them an opportunity to continue their education at a four-year liberal arts institution. It provides Centenary College the opportunity to attract and retain students with a proven record of academic success.

Both higher education institutions have full-time tenure track faculty with advanced academic and field experience credentials.

Both institutions have extensive support resources (i.e. library, online access, service courses, and adequate administrative, faculty, and staff).

In accordance with this Memorandum of Understanding, BPCC agrees to:

Inform students regarding the process of applying to Centenary College, including transcript evaluation.

Provide Centenary College with the BPCC application information to prospective transfer students.

Provide Centenary College with a point of contact to coordinate prospective student transfer.

Jointly with Centenary College, market this Articulation Agreement to prospective students.

Provide information about this Articulation Agreement on the BPCC website beginning immediately.

Provide information about this Articulation Agreement in the next published BPCC catalog.

In accordance with this Memorandum of Understanding, Centenary College agrees to:

Accept BPCC credit hours within the LA Transfer programs that have a minimum grade of a C.

Provide BPCC with the information and materials to provide Centenary College application information to prospective transfer students.

Inform students regarding the process of applying to BPCC, including transcript evaluation.

Provide BPCC with a point of contact to coordinate prospective student transfer.

Provide BPCC's application information to any Centenary applicant who resides within 75 miles of BPCC and is ineligible for acceptance into Centenary College.

Along with BPCC, jointly market this Articulation Agreement.

Provide information about this Articulation Agreement on the Centenary College website beginning immediately.

Provide information about this Articulation Agreement in the next published Centenary College catalog.

Upon completion of an Associate of Arts LA Transfer Associate's degree or Associate of Science LA Transfer Associate's degree at BPCC, a student may transfer to Centenary College as a junior, dependent upon the required minimum grade (C) in each course and the student's chosen major. BPCC coursework will transfer into Centenary College reflective of course hours earned at BPCC.
